

## MAVERICKS AAU BASKETBALL PAYMENT FORM – 7<sup>th</sup> to 11<sup>th</sup> Grades

**Fee includes:**

- 8 tournaments – approximately 24 games within the timeframe of April through July
  - Tournaments will be identified/specified at a later date
  - Includes entry fee and coaches travel expenses
  - Any tournaments beyond this will be extra and fees/expenses will be divided pro-rata amongst the players attending the game
- Team training and practice sessions three times per week (no practices during a tournament)
- Custom Uniforms
- Team gear including: balls, bags, scorebooks, clipboards, practice gear & equipment
- Gym practice time of approximately 6 hours per week in an insured facility starting late March
- AAU Club, Player and Coaches membership fees
- Gym/Practice Facility Insurance
- Coach Fee
- Administrative fees and expenses (e.g., phone, fax, mail, website, etc.)

Full payment of the Player Participation Fee with the other completed/signed forms is expected upon first practice.

The Player Participation Fee does **not** cover:

- Medical insurance. This is up to the player's family to provide.
- Player travel and lodging for travel tournaments – this is the parent's responsibility. A ground transport fee (TBD) will be assessed for each player participating in a travel tournament.
- Any additional tournaments played beyond the 8 covered in the Program will be funded by the families of the players who participate in the tournament. For example, a two day AAU tournament typically costs about \$250 - \$300 per team entry. Ten players on a team for a \$300 tournament would require each player's parent to pay \$30.00 each plus a pro rated portion of the coach's day fee of \$250/day and travel expenses, if any. Payment for this incremental tournament expense is to be collected prior to the tournament and an invoice from the club will be provided.

**Refunds:**

No refunds of any kind of the Player Participation Fee will be made after April 15 unless a player has a season ending injury or illness. In such a case, the refund will be pro-rated based on the amount of time the player has been with the club (# of days since the first practice divided by 120 days – the total days of the season) less \$250 for expenses incurred related to the player (i.e., insurances, uniforms, equipment, AAU memberships). There will be no refunds of the Player Participation Fee for a player asked to leave the team due to repeated violations of the Club's Code of Conduct, which each player and parent is asked to read and sign prior to the beginning of the season.
